

## COPYRIGHT TRANSFER FORM

The Editorial Office of the "Nihonkai Mathematical Journal" (NMJ) requests authors to transfer copyrights for their articles (including all the electronic versions, such as PDF files) to the NMJ. Please read this form carefully and complete, as appropriate, all the information requested and return the form to the Editorial Office. If an article was written jointly with (an)other author(s), the signing author needs to inform beforehand the coauthor(s) of the terms of this copyright transfer and that s/he is signing the transfer on the coauthor(s) behalf as their agent; and must obtain the coauthor(s) authorization to do so. The signing author shall bear responsibility for designating the coauthor(s) and must inform the NMJ of any changes in authorship. If the author's employer holds the copyright, the employer or an authorized representative of the employer should sign. If the author signs, it is understood that doing so is with the authorization of the employer and with the employer's acceptance of the terms of the transfer. The author(s) reserve(s) the right to use all or part of the subject article, without fee, in future works of their own. In such cases, the source (example: Nihonkai Math. J., 18, 1-7) should be indicated.

4. The Author agrees to include links to the article's home page (in the NMJ's home web) along with any electronically available copy of the article.
5. The Author warrants that s/he has the full power and authority to enter into this Agreement and to grant the rights granted in this Agreement.
6. The NMJ undertakes to publish the article by placing it on the NMJ's web.
